Activation of the second round of selection for admission to the Single-cycle master's degree program with limited access in

PHARMACY IN ENGLISH LANGUAGE (class LM-13)

Academic year 2021/2022

Regarding the provisions of the Call for Admission to the Single Cycle Master's Degree program with limited access in Pharmacy in English language (D.R. 812/2021, prot. 18152 of 08/04/2021), art. 8, as there are still vacancies following the completion of the first selection round, the second selection round is held to cover these positions for:

- n. Nineteen (19) places for Italian citizens, EU citizens and non-EU citizens legally residing in Italy under art. 26 of the law 189/2002;
- n. Eleven (11) places reserved for non-EU citizens residing abroad who are applying for a visa.

candidates who meet the requirements set out in art. 2 of the call, both the conditions referred to in the following points a) and b) must be fulfilled, under penalty of exclusion from the competition:

a) have taken the English TOLC-F test (CISIA online test) and passed with a score of at least 18 out of 50, by September 30th 2021 according to the methods, calendar and places made known by CISIA through the website: www.cisiaonline.it.

For information on registering for the English Tolc-F test, selection methods and evaluation criteria, see art. 3 of the Call.

b) apply for participation in the selection for inclusion in the ranking through the Delphi University online services site http://delphi.uniroma2.it in the period between September 7th and September 30th 2021 according to the methods, calendar and places made known by CISIA through the website: www.cisiaonline.it.

For information on how to enter the application form on the Delphi portal, see art. 5 of the Call.

PLEASE NOTE:

The candidate who has already passed the English TOLC-F in the previous selection and wants to compete for the September selection using the same score does not have to register again with the CISIA but must re-submit the application to participate in the competition on the Delphi platform.

 $\sqrt{}$ The candidate who wants to improve the score already obtained can repeat the test but, in this case, is required to re-register for the test both on the CISIA and Delphi platforms.

At the University of Rome "Tor Vergata", the English TOLC-F will be delivered on September 14th 2021, 10:30 a.m.

Important: there is a maximum number of students admitted to taking the test based on the capacity of the virtual classroom in which the test itself takes place. For this reason, candidates are invited to register in time for the test through the CISIA website. Upon completion of the available positions, registrations will be closed.

The General Ranking of merit.

The General Ranking of merit will be formed by inserting only the candidates who have regularly registered for the selection respecting the set deadlines and who have taken the English TOLC-F CISIA at one of the participating universities during the period indicated.

The General ranking of merit, formulated and approved by the Commission, will be formed based on the score obtained in the English TOLC-F.

A specific ranking will be published for non-EU citizens residing abroad applying for a study visa.

The publication of the ranking will be valid in all respects as an official communication of the results.

There is no other form of communication of the ranking or any supplementary rankings.

The publication of the general ranking of merit is expected from October 7th 2021.

Successful candidates must confirm their place by proceeding with enrolment by 14/10/2021.

Possible supplementary rankings.

If, upon expiration of the enrolment, they turn out renouncers, on 21/10/2021 a supplementary

ranking and a notice will be published regarding all the methods and procedures to be followed for

filling the places made available.

Registration and payment/validation of fees and contributions.

Successful candidates in the merit rankings must confirm enrollment by paying the first bulletin

definitely by October 14th, 2021 following the procedures that will be published at the same time

as the ranking is published.

At the same time as the publication of the merit rankings, the transfer and transfer procedures will

also be published, which the winning students must complete within the same deadlines set for

enrollment.

Any changes concerning what is indicated will be communicated on the institutional websites of the

University, the Science Macro Area and the CdLM single cycle in Pharmacy.

PLEASE NOTE: Winning candidates who do not enrol within the deadlines described will be

regarded as renouncers.
