Their enrollment will be subject to the validity of the documentation and educational qualification in their possession as required by current legislation on the subject.

N.B.: The qualification obtained abroad must be translated, legalized and accompanied by the Declaration of value issued by the Italian embassy abroad. **As an alternative** to the Declaration of value, the certificate of comparability issued by CIMEA has to be presented and can be requested online at the following link:

a) By August 31st, 2020:

enter the enrollment application on the University of Delphi online services portal and upload the following documents:

- 1. Copy of a valid identification document / passport
- 2.Certificate of comparability issued by CIMEA or receipt of payment for the request for this certificate. Alternatively, **if already in possession**, the Declaration of Value (DOV) of the translated and legalized diploma issued by the embassy.
- 3. For non-EU citizens only: a copy of the residence permit (Temporary Residence Permit) or Residence Card.

Only after the International Students Office, verifies the completeness and validity of the documentation, will generate the bulletin of the first instalment, the payment of which will confirm enrollment in the CdLMCU in Pharmacy.

b) By 4th September 2020: pay the bulletin to confirm enrolment.

CANDIDATES WITH QUALIFICATIONS OBTAINED IN ITALY

Students included in the ranking from no. 1 to n. 50 in possession of a qualification obtained in Italy must carry out the enrolment procedure **no later than 4**th **September, 2020**, under penalty of exclusion from the ranking by carrying out the procedures referred to in points a) and b):

a) Online registration, payment of the FIRST INSTALMENT and related validation

Fill in the evaluation questionnaire on the website http://www.quest.uniroma2.it. A questionnaire code (C.Q.) will be released that must be entered when the payment is validated. The QC is valid for five days from the date of filling in the questionnaire, after which it must be completed. Then:

- 1. Connect to the site of the online Services: http://delphi.uniroma2.it
- 2. Select Student Area, Key 2, Enrollment;
- 3. Select "a" "Start application procedures" select Study course in presence;
- 4. Read all the instructions carefully, then select the Macro area, then select "I passed the admission test" then enter all the required data (the system will allow enrollment in the Course for which the test was passed)
- 5. Print the bulletin for the payment of the first installment (if expected);
- 6. Pay the amount due through the PagoPa system. This method allows you to make the payment through a plurality of channels, physical or online. Further information on payment methods are available at the following link: http://studenti.uniroma2.it/pagamento/
- 7. Connect again to the site of the online services, then proceed with the validation of the payment through the button "Validate PagoPA"

8. The system will issue your personal I.D. number (matricola) and password, which must be kept carefully as they will be essential for future access to the University's computer services.

Students with a disability equal to or greater than 66% or with recognition of disabilities pursuant to art. 3, paragraphs 1 and 3 of the law of February 05 1992, n. 104, to be totally exempt from paying university fees and contributions, for enrollment they must deliver directly to the Technical Secretariat of the Commission for the inclusion of students with disabilities and SLD (CARIS) via del Politecnico, 1 (Faculty of Engineering) the documentation issued by the competent authorities certifying the state of invalidity.

Further information regarding the other cases of total or partial exemption from payment of university fees and contributions will be available in the Student Guide A.A. 2020/2021.

PLEASE NOTE: Admitted candidates who have not completed the enrollment within the terms described will be considered to have withdrawn and the vacant places will be announced in the Second Selection Round in September.

There are no scrolling rankings for this selection.

b) Presentation of the documentation at the office of the Student Secretariat

Once the payment has been validated, the following documents must be presented within 30 days at the Student Secretariat, Science Area, Via della Ricerca Scientifica 1 - 00133 Rome, during public receiving hours:

- 1. the application for registration and the form for the "centro di calcolo" both pre-filled, to be signed at the time of presentation, with passport-size photos already applied in the appropriate spaces;
- 2. a passport-size photo identical to those applied on the applications (for the university booklet);
- 3. photocopy of a valid identification document
- 4. photocopy of the payment receipt (excluding those who are entitled to full exemption from the payment of tuition and university fees)
- 5. part of the sheet generated by the payment validation procedure. This part of the sheet is marked with the words "to be delivered to the Student Office".

PLEASE NOTE:

- Applications with incomplete documentation will not be accepted.
- Validation of payment and delivery of the aforementioned documentation to the competent Student Secretariat are essential to be enrolled.
- If the documentation is not presented within 30 days of payment of the first instalment, the credentials for access to your online form and to the University services will be deactivated.

IMPORTANT: The procedure referred to in point b) can be updated in relation to the containment and management measures of the epidemiological emergency from COVID-19, taken by the competent institutions.
