The candidates included in the general ranking, from no. 1 to n. 30, will have to formalize the enrollment procedures through the International Students Office, Via Cracovia n. 50, 00133 ROME - Building D floor 0 ([studenti.stranieri@uniroma2.it](mailto:studenti.stranieri@uniroma2.it)) following the process below. Their enrollment will be subject to the validity of the documentation and educational qualification in their possession as required by the current legislation on the subject.

To be regularly enrolled in the single-cycle Master's Degree Program in Pharmacy, both of the obligations referred to in points a) and point b) must be carried out within the following deadlines:

**Eligible candidates who do not enroll within the deadlines described will be regarded as renouncers.**



**a) By 31<sup>st</sup> August 2020:**

**enter the enrollment application on the University of Delphi online services portal and upload the following documents:**

1. Copy of the summary Pdf of the pre-enrollment application made on the University platform
2. Copy of a valid identification document / passport
3. Certificate of comparability issued by CIMEA or receipt of payment for the request of this certificate. Alternatively, **if already in possession**, the Declaration of Value (DOV) of the translated and legalized diploma issued by the embassy.

**Only after the International Students Office verifies the completeness and validity of the documentation, the bulletin of the first instalment will be generated, the payment of which will confirm enrollment in the CdLMCU in Pharmacy.**

**b) By 4<sup>th</sup> September 2020:**

1. **pay the bulletin to confirm enrolment.**
