To access the practical evaluation test, students must pay a fee that includes both the regional qualification fee and the state tax.

****Regional Qualification Fee****

The amount of €113.62 is the qualification fee required to practice the professional activity. This fee is a regional tax that benefits DiSCo Lazio, the Regional Body for the Right to Study and Knowledge. Therefore, this amount applies specifically to graduates in the Lazio Region, and it is important to note both the fee amount and the designated beneficiary for the payment.

Test Date: 2 JULY 2026 – 9:00 am second floor PP1

The test will be conducted as follows:

1. Evaluation of the Internship Booklet by the evaluation Committee.
2. An oral test will be conducted in Italian. Candidates must demonstrate knowledge in the following subjects:

- Italian Pharmaceutical Legislation
- European Pharmaceutical Legislation
- Commercial Law

Candidates will be classified as "suitable" or "unsuitable" based on the evaluation results.

Students who do not pass the Practical Evaluation Test ("unsuitable") will not be permitted to participate in the graduation session and they will have to repeat the 6-month internship"

Participation in the practical evaluation test is mandatory for the graduation session.

All candidates must bring a copy of their payment receipt to confirm their eligibility for the test on the exam day.
